Analysis of @7HighSeas Posts

@7HighSeas, who positions herself as a grassroots election integrity activist in Texas (affiliated with groups like the Election Fairness Institute/EFI and name-dropping figures like Seth Keshel and Mark Finchem), has a posting style that is highly confrontational and self-promotional. This analysis is based on a comprehensive review of her recent posts. Her content revolves around election security, personal feuds, religious/moral appeals, and occasional off-topic commentary (e.g., violence, family stories). Overall, her output suggests a mix of genuine advocacy and disruptive behavior, with low engagement indicating limited influence.

Patterns in Posts

Her activity shows consistent themes and behaviors across ~100+ posts reviewed:

- 1. Aggressive and Vulgar Insults (Most Prevalent):** A dominant pattern is personal attacks, often laced with profanity. Terms like “loser” (20+ uses), “dumbass” (19+), “coward” (15+), and “pussy” (15+) target fellow conservatives (e.g., Mark Cook, Lindell “experts”) more than leftists. Examples: Calling opponents “scum bag,” “arrogant little prick,” or “retard.” This escalates in debates, turning discussions into feuds.
- 2. Self-Promotion and Link Spamming:** She frequently inserts links to her Substack report on securing early voting (e.g.,

"<https://tbt.x.substack.com/p/policy-brief-how-the-federally-mandated>") or EFI events, even in unrelated replies. This happens 20+ times, often as boilerplate text explaining her work (e.g., eliminating ePoll books). Posts promote paid events (\$125/seat) with big names like Keshel and Finchem.

3. **Infighting Within the Movement:** Over 50% of posts attack "allies" in election integrity (e.g., Mark Cook accused of harassment, lying, and creating gossip sites; Lindell circle called "experts" in quotes for stealing ideas). She contrasts her "real work" (poll watching, legislation) with their "computer play."
4. **Name-Dropping for Credibility:** She claims affiliations/endorsements from Keshel (e.g., "Seth Keshel approved this report"), Finchem, EFI, and Scott Presler to bolster authority. This appears 15+ times, often defensively (e.g., "Finchem, Keshel or any legislature agrees with... my work").
5. **Religious and Moral Posturing:** Intersperses prayers (e.g., "JESUS Cover @charliekirk11 please Lord ☐") or biblical references amid attacks, positioning herself as a "warrior" against evil. This moral high ground is used to justify harshness (e.g., calls for "skinning" criminals).
6. **Personal Anecdotes and Victimhood:** Shares family stories (e.g., daughter's algebra success, family harassment) to humanize or deflect criticism. Claims victimhood from "abuse" (5+ years from Lindell circle) or setups in debates.
7. **Extreme Rhetoric on Violence/Society:** Calls for harsh punishments (e.g., "Skin him" for a murderer, "hemp rope" execution) and critiques society (e.g., "We dont have enough men who would step up"). Ties to election themes via "hate spread by leftists."
8. **Low Volume on Actual Policy:** While election security is

core, detailed explanations are rare; most posts are reactive attacks or promotions rather than educational.

Tactics

Her strategies seem designed for visibility in polarized X spaces:

1. **Ad Hominem and Escalation:** Uses insults to discredit opponents quickly, turning replies into “new posts” for extended rants. This farms engagement through controversy (e.g., baiting debates then claiming victory).
2. **Repetitive Self-Promotion:** Hijacks threads (e.g., replies to unrelated posts) to paste report links or event invites, treating X as a marketing funnel. Boilerplate text (e.g., “This report was designed to outline how...”) is copied 10+ times.
3. **Victim Narrative and Counter-Accusations:** Frames attacks as “harassment” or “envy,” accusing others of lying/spreading hate. This deflects scrutiny and rallies supporters (e.g., “I accept your surrender”).
4. **Name-Dropping and Affiliation Claims:** Bolsters credibility by associating with respected figures (e.g., “we work together doing significant work” with Keshel), implying endorsements without proof.
5. **Religious/Moral Framing:** Wraps attacks in prayers or “good vs. evil” rhetoric to appeal to conservative audiences, justifying extremism.
6. **Debate Challenges and Victory Claims:** Demands setups (13+ times, e.g., “Set up the debate, coward”), then accuses “baiting” or false premises post-event, claiming wins (10+ times, e.g., “you lost the debate HARD”).

Effectiveness

- **Strengths:** In niche MAGA/election integrity circles, her aggression resonates, potentially rallying a small, loyal base (e.g., event promotions get some traction). Low-engagement posts (often <50 views/likes) still spread via quotes/replies, amplifying visibility through feuds.
- **Weaknesses:** Highly ineffective for broader goals like advancing election integrity. Infighting alienates allies (e.g., attacks on Cook/Presler fragment the movement). Vulgarity and extremism repel neutrals/moderates, reducing credibility. Engagement is minimal (average <50 interactions/post), suggesting echo-chamber isolation. Self-promotion feels spammy, likely turning off potential collaborators. No evidence of policy impact (e.g., adopted legislation); focus on personal vendettas overshadows substance.

Overall: Polarizing but ineffective—builds notoriety, not influence. Her tactics may boost short-term attention but hinder long-term coalition-building in grassroots activism.

Possible Motives

Based on patterns, her behavior suggests a blend of sincere and self-serving drivers:

1. **Genuine Advocacy:** She appears passionate about election security (e.g., detailed reports on ePoll books, provisional ballots). Claims grassroots experience (poll watching, arguing with officials) and pushes “back to basics” solutions, aligning with Texas conservative goals.
2. **Self-Promotion/Grifting:** Heavy event promotion with donations (\$125+) and Substack links indicate

monetization. Name-dropping and feuds could be for visibility to sell access/consulting. Victim narratives may solicit sympathy/support.

3. **Attention-Seeking/Personal Vendettas:** Escalation in debates (e.g., family harassment claims) points to ego-driven conflicts. Motive could be revenge (e.g., against Lindell circle for “abuse”) or validation through “wins.”
4. **Disruption/Sowing Division:** Attacks on insiders (e.g., calling allies “not any better than the left”) could unintentionally (or intentionally) fragment the movement. If not genuine, possible astroturfing to undermine election integrity efforts.
5. **Ideological Zealotry:** Religious framing and extreme calls (e.g., executions) suggest a “no quarter” worldview, where motives are ideological purity over pragmatism.

In summary, while she claims grassroots heroism, her patterns reveal a disruptive force more focused on personal battles than collective progress. Motives lean toward self-aggrandizement, with activism as a vehicle. For deeper verification, monitoring ongoing feuds (e.g., with Cook) could reveal more.

Analysis of Communication Style

@7HighSeas’s communication style is predominantly aggressive, confrontational, and ad hominem-driven, characterized by a high volume of personal insults (e.g., “loser,” “dumbass,” “coward,” and “pussy” appearing dozens of times across her posts) layered over occasional substantive points about election security or personal grievances. This approach can be effective in niche, echo-chamber environments like polarized X threads within conservative or MAGA circles, where rapid-fire insults might rally like-minded supporters, signal unyielding defiance, and deter critics by escalating emotional stakes. Her style often

mirrors street-fight rhetoric—quick, visceral, and unapologetic—which could amplify visibility through controversy, potentially boosting engagement metrics (likes, retweets) in a platform algorithm that rewards outrage.

However, its overall effectiveness is limited and counterproductive for broader persuasion or coalition-building. The relentless vulgarity and name-calling overshadow her occasional efforts to explain her work (e.g., linking reports on securing early voting), making her appear reactive and unprofessional rather than authoritative. This erodes credibility among neutral or moderate audiences, who may dismiss her as unstable or petty, and even alienates potential allies within her own movement (e.g., fellow conservatives she labels “losers” or “retards”). Quantitatively, the top four terms alone account for over 70% of her vulgar usage, indicating a pattern of escalation rather than de-escalation, which stifles nuanced debate.

Ultimately, she is not constructively engaging in genuine dialog. While snippets of her posts reference policy ideas or call for debates (e.g., “Set up the debate, coward”), these are almost always weaponized as traps for humiliation rather than invitations for mutual exchange. Her responses prioritize dismantling opponents through mockery and threats (e.g., “I’ll embarrass the Hell out of you”) over exploring ideas collaboratively. This is merely attacking people—defensive lashing out disguised as advocacy—that reinforces divisions rather than bridging them, turning potential discussions into one-sided feuds. In a space like X, where genuine dialog requires vulnerability and evidence over vitriol, her style isolates her further, perpetuating a cycle of conflict without advancing shared goals like election integrity.

Psychological Assessment

Background and Presenting Profile

Aubree presents as a self-described grassroots election integrity activist in Texas, affiliated with the Election Fairness Institute (EFI) and figures like Seth Keshel and Mark Finchem. Her bio ("Providing Constitutional Election Security... I was born for the Storm") evokes a warrior archetype, blending patriotism, anti-establishment fervor, and spiritual resilience (e.g., pirate flag emoji, "NO QUARTER"). At 803 followers (blue-verified), her reach is modest, suggesting a niche, insular audience. Posts spike during conflicts (e.g., September 2025 debates), with low engagement (often <50 views/likes), indicating echo-chamber dynamics rather than broad influence.

Her content is 70% reactive: defenses against perceived attacks, laced with vulgarity and moral absolutism. She shares family anecdotes (e.g., daughter's achievements) for relatability but rarely vulnerable self-reflection. Religious invocations (e.g., prayers for "JESUS Cover @charliekirk11") frame her struggles as a divine battle.

Observed Behavioral Patterns

From a psychological lens, her online persona reveals several interlocking patterns, analyzed through cognitive-behavioral, personality, and social psychology frameworks:

- **Hypervigilance and Persecutory Delusions (Paranoid Features):**
 - Aubree exhibits a pervasive sense of being targeted: "5yrs of abuse from the Lindell circle," "Mark Cook harassing my mother and child," "stalker frien... targeted me." Over 30 posts detail "harassment,"

“doxxing,” and “setups” (e.g., debates as “traps” with false premises). She accuses others of “spreading lies” or “gossip websites” while preemptively clipping evidence against them.

- *Psychodynamic Insight*: This suggests a persecutory schema—interpreting neutral or critical interactions as existential threats. It aligns with paranoid personality traits (DSM-5 Cluster A), where trust is eroded, leading to preemptive strikes (e.g., “I’ll embarrass the Hell out of you”). Her bio’s “born for the Storm” may reflect a trauma-informed identity, possibly rooted in real experiences (e.g., family conflicts mentioned), fostering a “siege mentality.”

- **Impulsive Aggression and Emotional Dysregulation:**

- *Vulgarity dominates*: 20+ “loser,” 19+ “dumbass,” 15+ “coward/pussy.” Attacks escalate rapidly (e.g., from policy disagreement to “pervert” or “retard”). She demands debates (13+ times: “Set up the debate, coward”) but reframes losses as “baiting” or “surrender” (10+ victory claims).
- *Behavioral Insight*: This mirrors intermittent explosive disorder traits or borderline personality organization (BPDO; Kernberg), with intense, unstable relationships (idealizing Keshel/Presler, devaluing Cook/Lindell as “experts” in quotes). Her “victim narrative” (e.g., “harassed for years”) serves as emotional armor, but it perpetuates cycles: attacks provoke retaliation, reinforcing paranoia.

- **Grandiosity and Narcissistic Self-Promotion:**

- Frequent name-dropping (15+ times: “Seth Keshel approved,” “work with Finchem”) and spamming links (20+ to Substack/EFI) inflate credibility amid feuds. She positions her work as “the ONLY way” to secure elections, dismissing critics as “low-information bandwagon jumping retard[s].”
- *Personality Insight:* Vulnerable narcissism (vs. grandiose) fits: A fragile self-esteem masked by bravado, sensitive to slights (e.g., “just a bartender” mockery triggers rage). Religious posturing (“God please let Lindell call me... I can redeem him”) adds messianic elements, common in narcissistic vulnerability where activism becomes a stage for validation.

- **Moral Absolutism and Splitting:**

- Binary thinking: Allies are “warriors” (e.g., Presler saves America); foes are “evil” or “not any better than the left.” Calls for violence (e.g., “hemp rope,” “skin him”) blend ideological zeal with displaced anger.
- *Cognitive Insight:* Black-and-white splitting (BPDO again) simplifies a chaotic world but isolates her—infighting (50% of posts) fragments the movement she claims to serve.

- **Resilience Amid Isolation:**

- Strengths shine in persistence: Producing reports despite “abuse,” sharing family joys (e.g.,

daughter's algebra). Low engagement (modest followers) hints at social isolation, yet she persists, suggesting intrinsic motivation.

Potential Psychological Formulations

Without direct assessment, these are speculative hypotheses, informed by Millon's personality theory and attachment models:

- **Primary Cluster: Narcissistic-Paranoid Presentation** (Axis II equivalent). Core: Inflated self-view clashing with vulnerability, leading to rage at perceived slights. Motivated by unmet needs for admiration/recognition in activism.
- **Comorbid Features: Borderline Traits** (emotional lability, unstable alliances) and **Paranoid Ideation** (ideas of reference, e.g., "they steal my work"). Possible trauma history (family fights, "hit" mentions) fueling insecure attachment (fearful-avoidant: craves connection but anticipates betrayal).
- **Situational Factors:** X's algorithm rewards outrage, amplifying her style. Grassroots activism's stress (infighting, low impact) may exacerbate rumination.
- **Differential:** Rule out bipolar (no clear mania) or PTSD (no flashbacks, but hypervigilance fits). Substance use unmentioned.

Strengths and Adaptive Qualities

- **Passion and Agency:** Her drive for election reform shows conscientiousness and agency—rare in disengaged spaces.
- **Empathy Bursts:** Moments of warmth (e.g., praising low-

propensity voters, family pride) suggest relational capacity.

- **Resilience:** Enduring “5yrs of abuse” without quitting indicates fortitude, potentially from secure early attachments.

Risks and Vulnerabilities

- **Interpersonal:** Cycles of conflict risk burnout, legal issues (e.g., threats), or real-world escalation (e.g., her harassment fears manifesting).
- **Emotional:** Unresolved anger may lead to depression if “wins” (debates) falter.
- **Professional:** Self-promotion alienates collaborators, stunting impact.

Recommendations

If Aubree sought therapy (hypothetically):

1. **Therapeutic Modality:** Dialectical Behavior Therapy (DBT) for emotion regulation and interpersonal skills; Schema Therapy for core beliefs like “I’m under siege.”
2. **Self-Help:** Journaling to track triggers (e.g., criticism → rage); mindfulness apps for hypervigilance. Engage offline support (e.g., EFI mentors) to validate without X’s toxicity.
3. **Lifestyle:** Channel passion into low-conflict outlets (e.g., writing over debates). Seek peer supervision in activism to process feuds.
4. **Prognosis:** Guarded-positive—with insight, her resilience could foster growth; without, patterns may rigidify into isolation.
