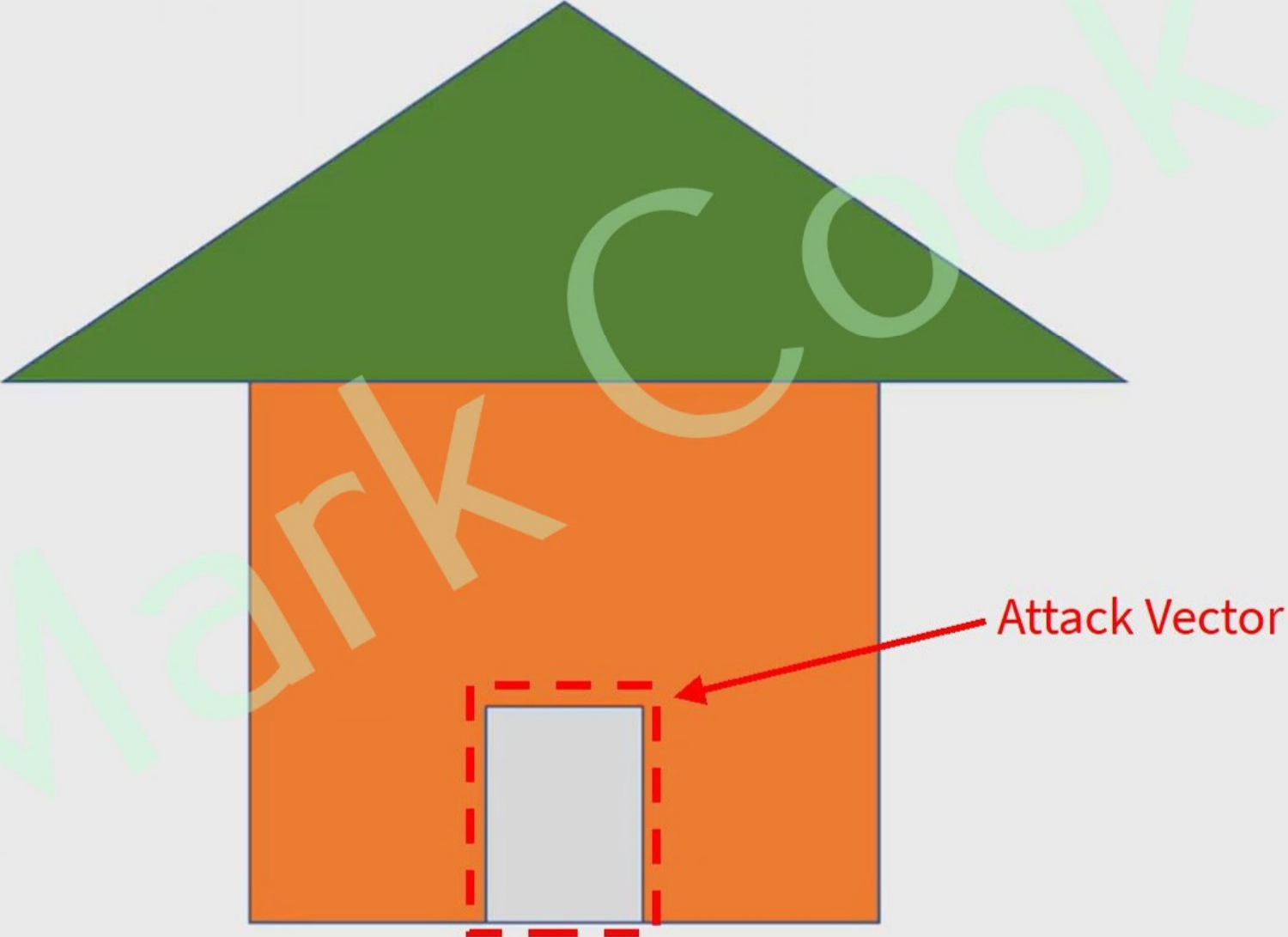

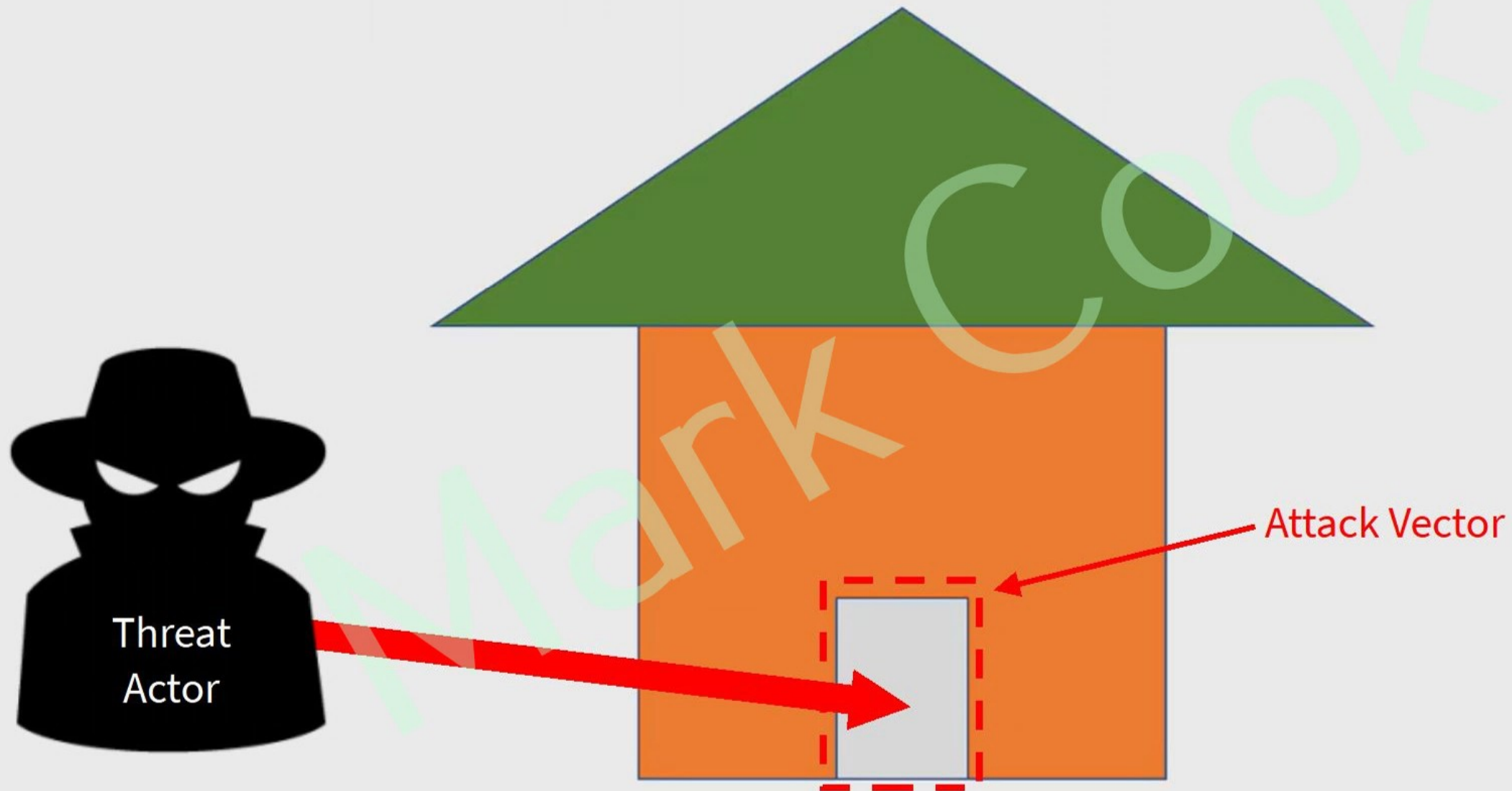
What is an Attack Vector?



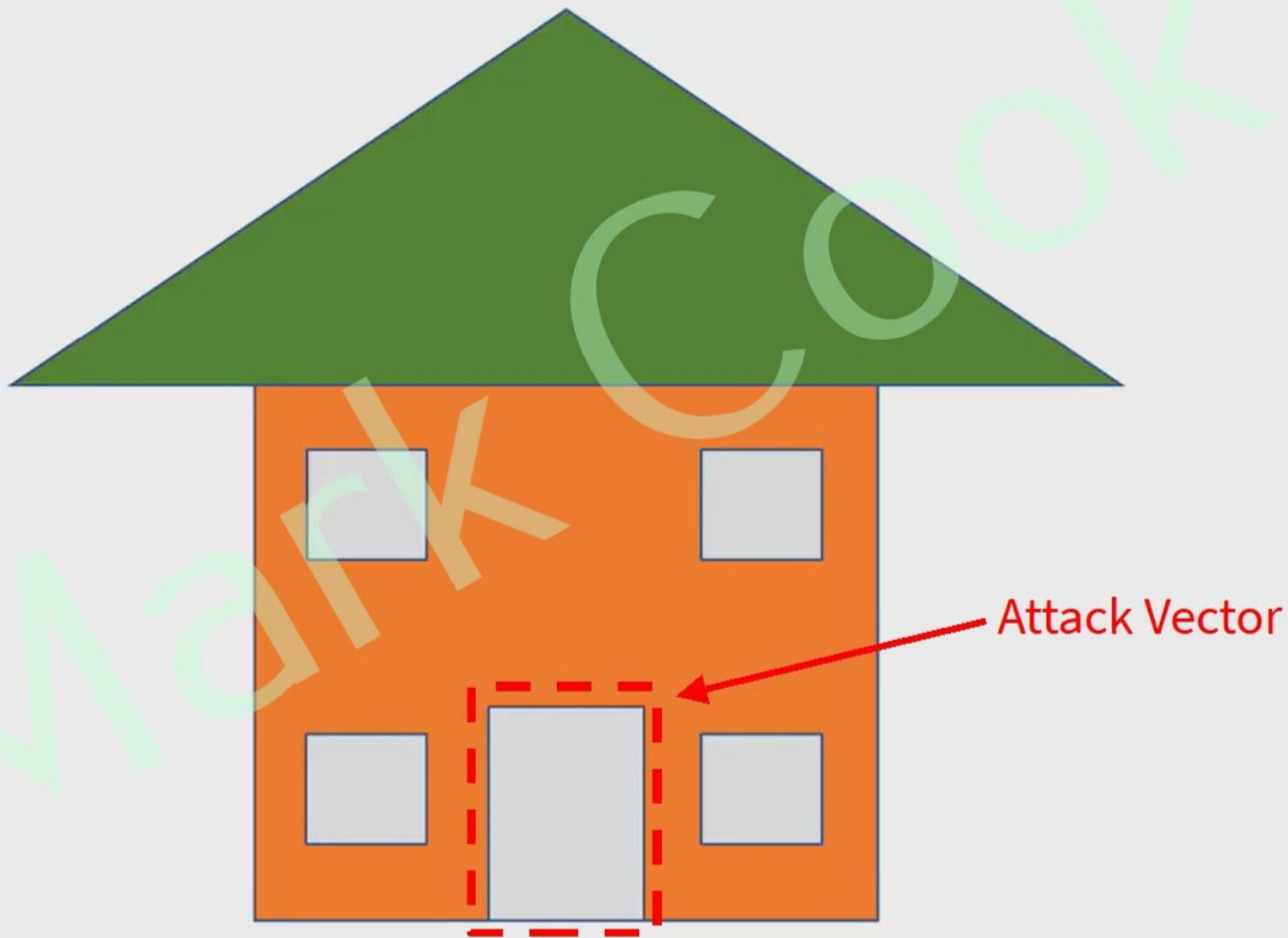
What is an Threat Actor?



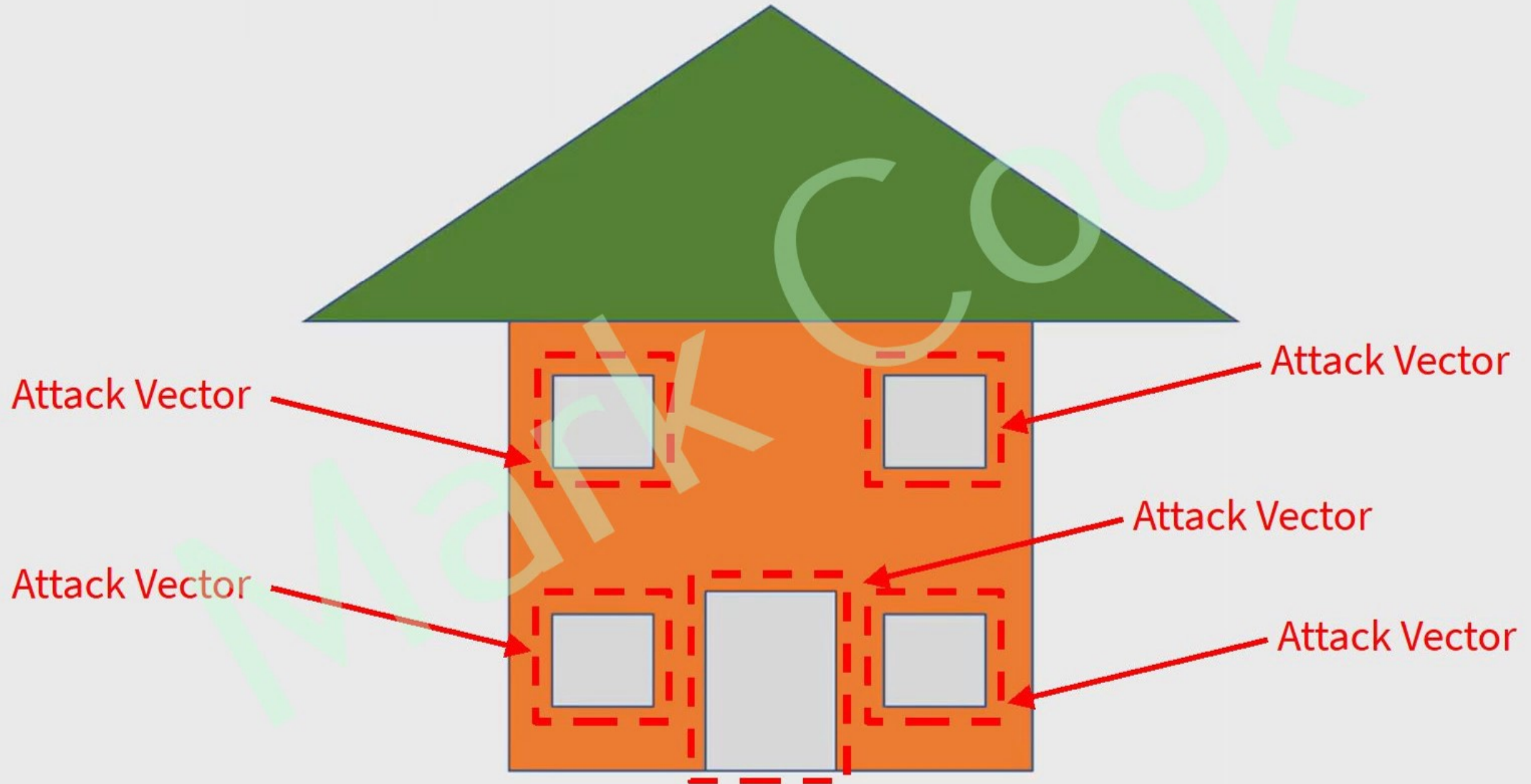
Threat Actors exploit Attack Vectors



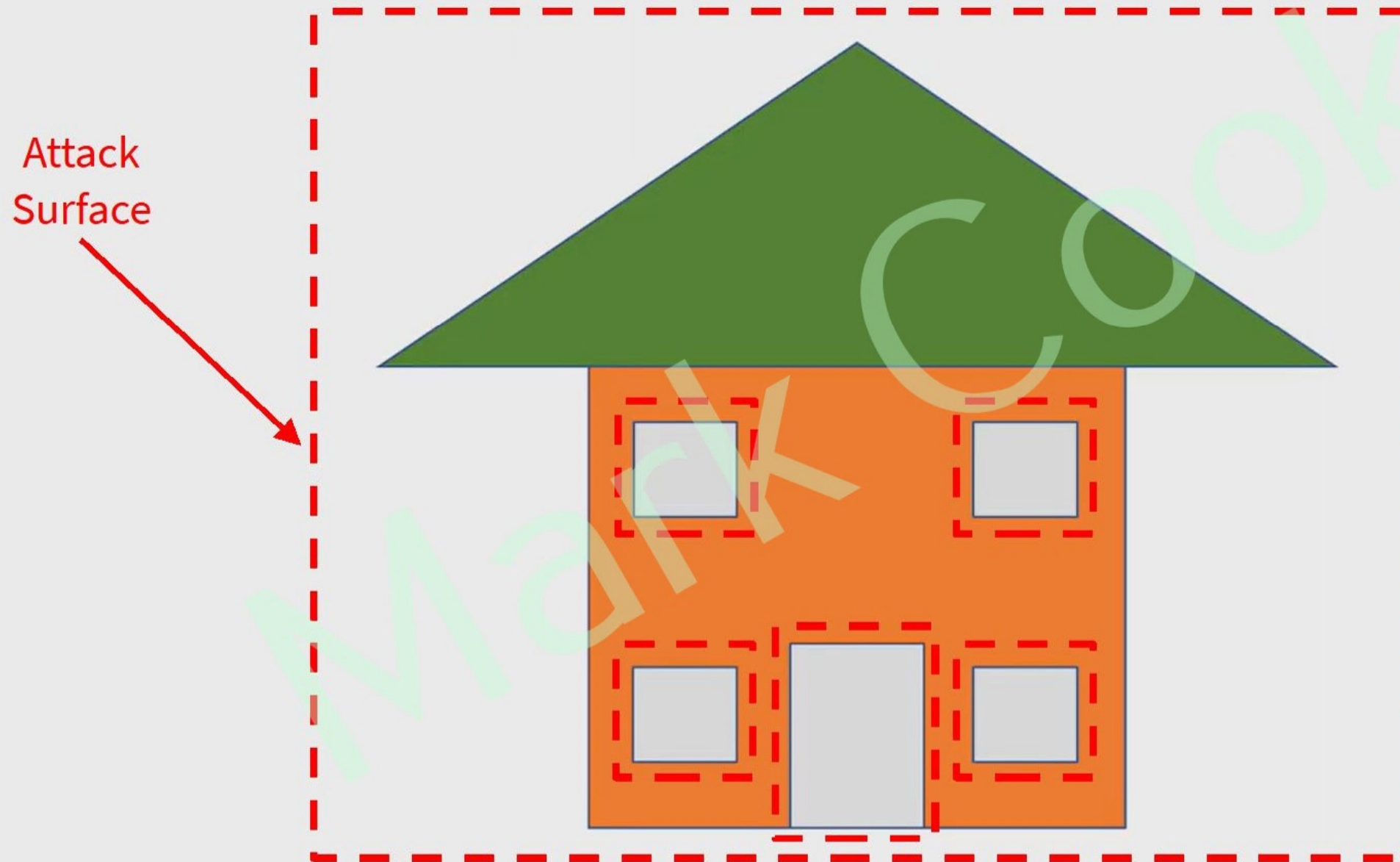

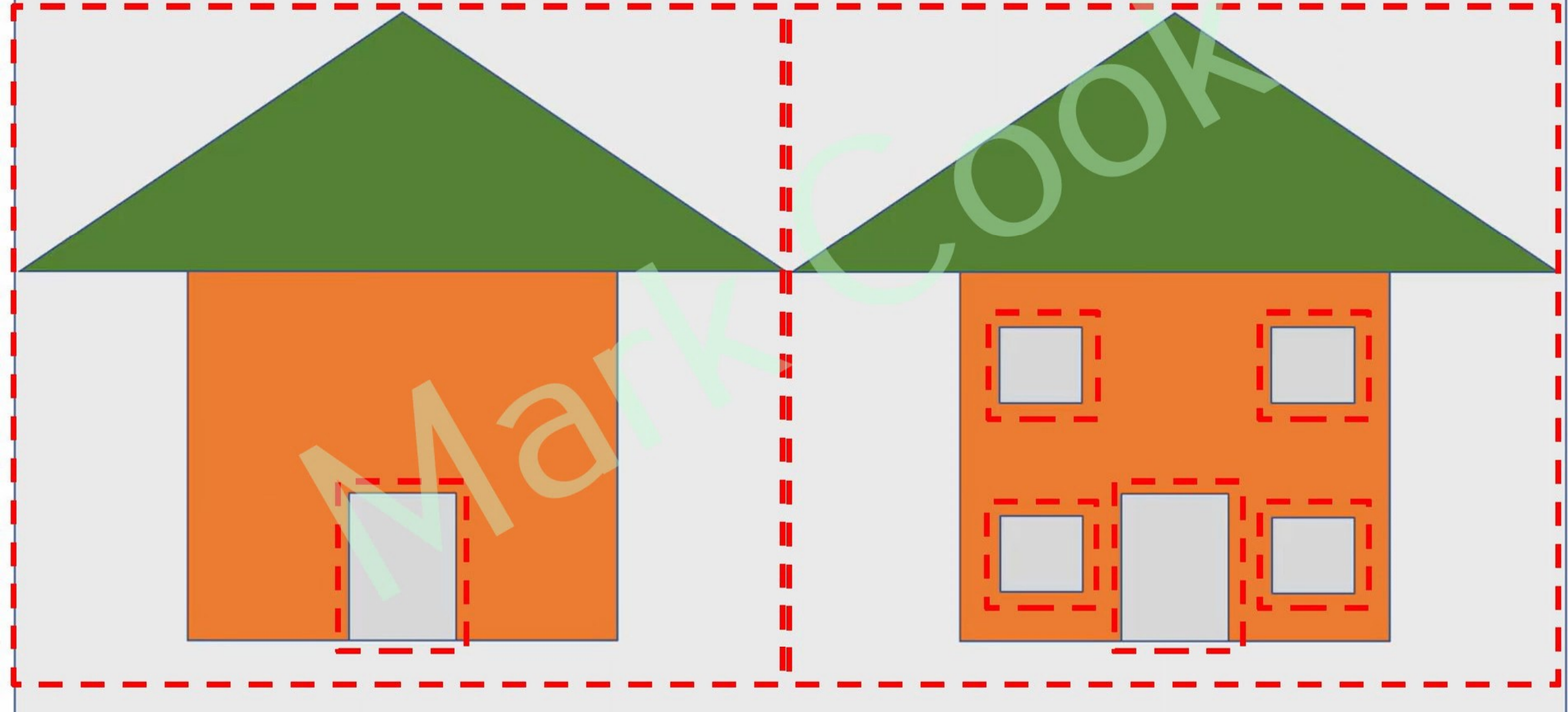
What is an Attack Surface?



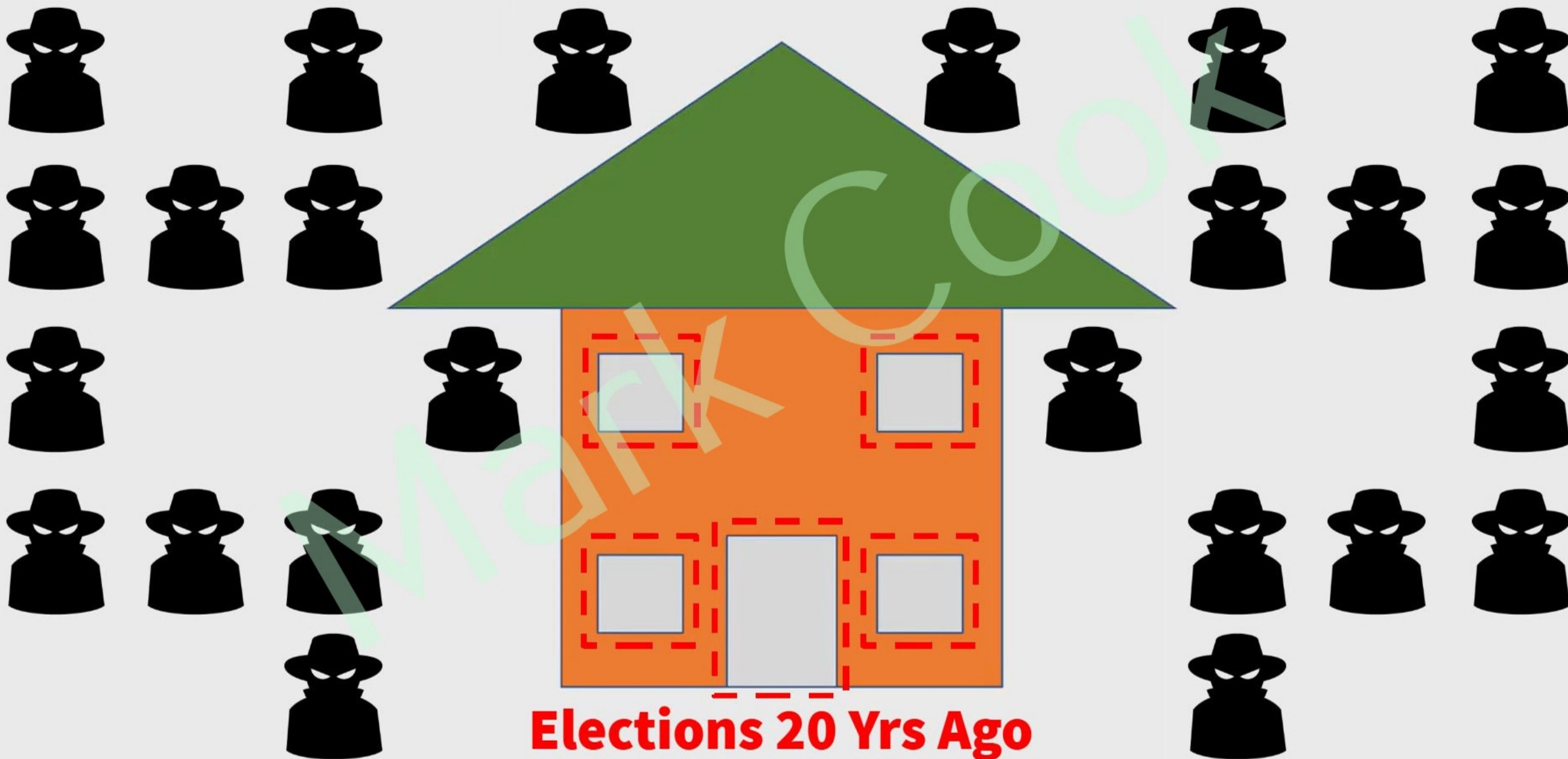
Which is safer?

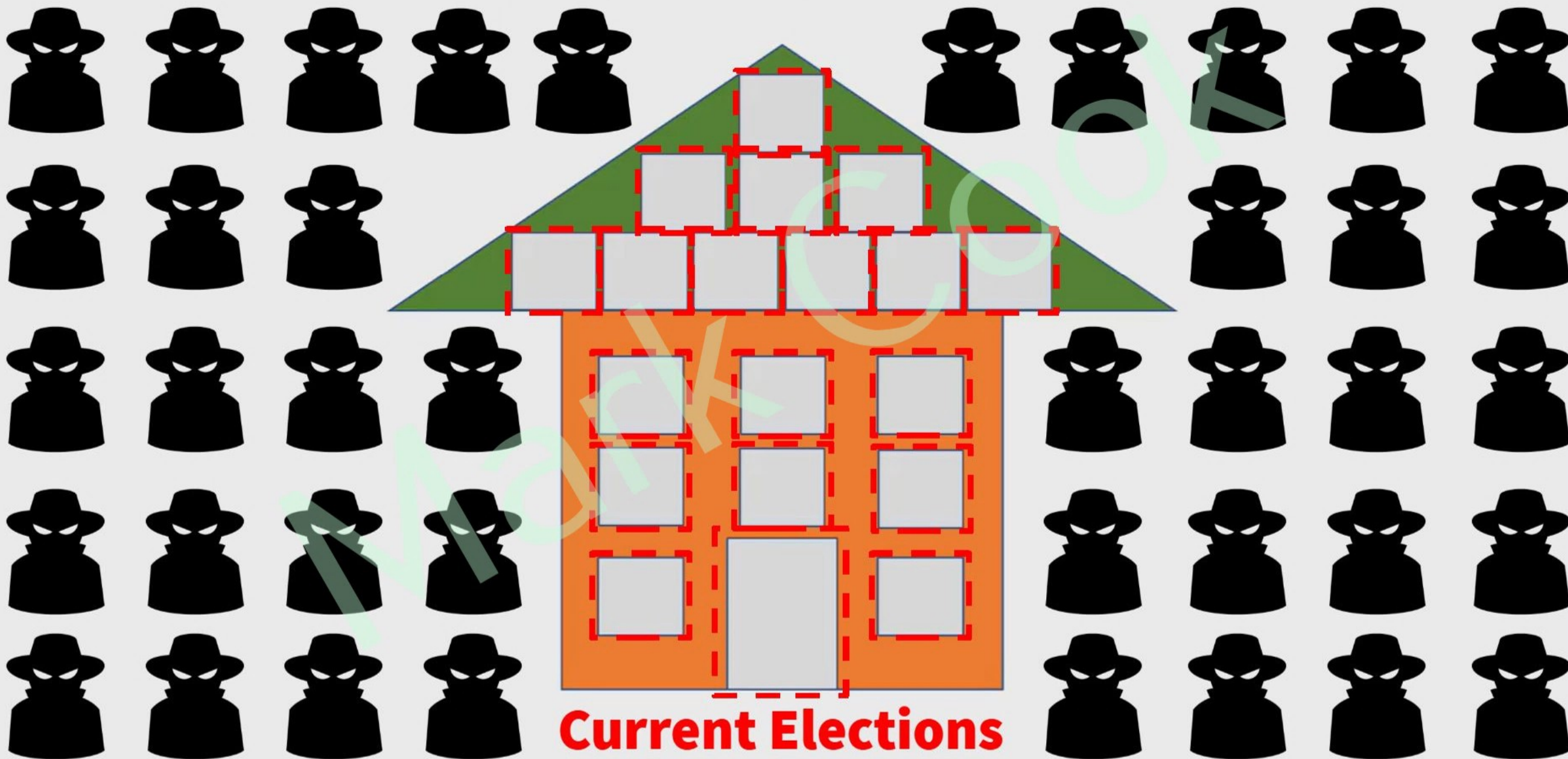

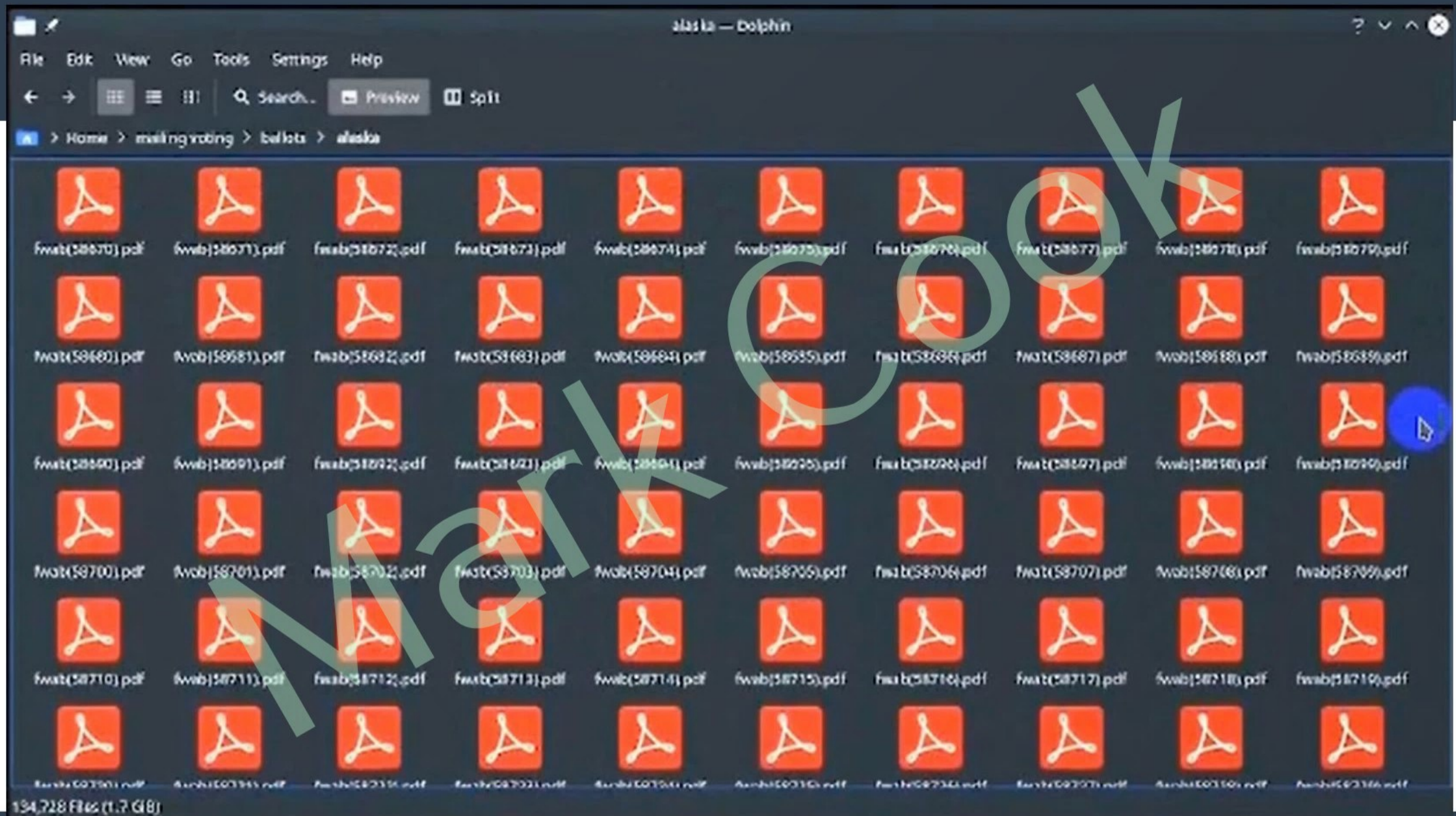

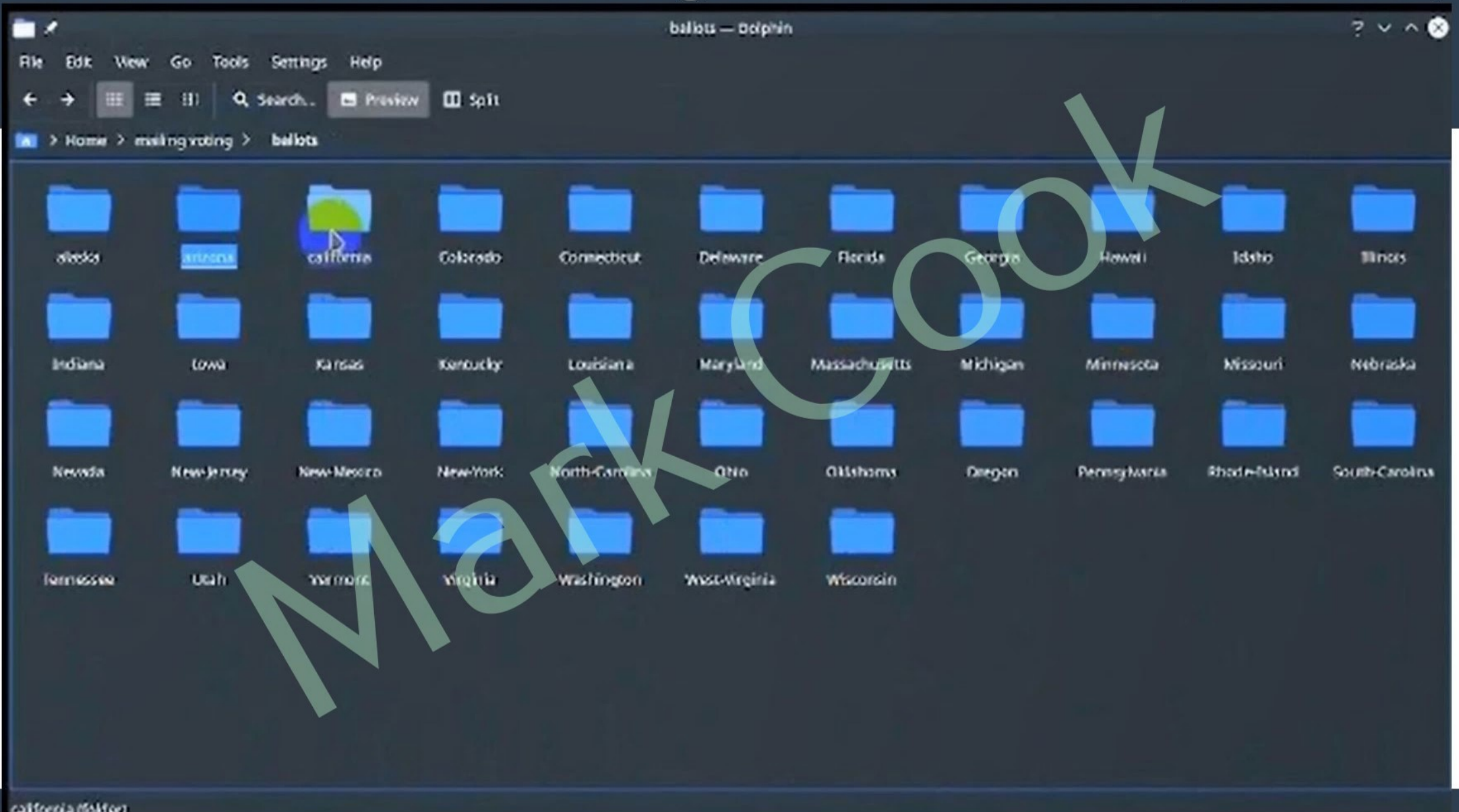

Collin County, TX – Voter list inconsistencies

The first issue is that months after an election, voters are removed from the State List. The example below comes from the State List of Voters for Collin County for the March 1, 2022 Primary Election. Notice that from May 29 to May 30 a couple from Plano was removed from the State list of voters. We checked with the County and they have confirmed that they in fact did vote. So what is happening in the State records for this couple to be removed months after the election?

Here is a chart from Galveston County. This chart was downloaded from the SOS website on July 2, 2022, and July 24, 2022 (four months after the primary). Notice that there are 2 votes removed from the Official Election Day Voting Information.

The election numbers should be a fixed set of names and VUIDs **at the time of certification**. Why are numbers and names changing months after the election? And who is doing this? Is there something in the system that makes these changes?

These data changes do not appear to be happening at the county level. So what is happening at the State level? The SOS website has a disclaimer that says that they do not alter or modify data provided by the county.

CLEVELAND, Ohio – A company that helped register over 11,000 Cuyahoga County voters last year is being referred for investigation after the local Board of Elections flagged at least 18 irregularities in their voter records, including mis-matched signatures and address changes voters said they didn't initiate.

In a Monday vote, the Cuyahoga County Board of Elections formally asked Ohio Secretary of State Frank LaRose's office to probe Black Fork Strategies, a registration drive group, to determine whether the questionable registrations are representative of a more widespread problem.

‘This Is Fraud’: Ohio Investigators Looking Into Suspect Voter Registrations Tied To Left-Wing Firm

Allegations of fraud have been tied to Black Fork Strategies, a left-wing Ohio firm committed to ‘building long-term progressive power.’

Earlier this year, Cincinnati-area voters Cassandra and Harry Scott were puzzled to receive voter registration updates showing they had changed their address. They hadn't.

The [Hamilton County Board of Elections](#) had received two registration forms for the voters from [Black Fork Strategies LLC](#), an Ohio-based “engagement firm that focuses on all aspects of community and electoral field work.” Elections Board staff made the requested changes in the voter rolls and, per Ohio law, sent notice to the voters at their “new address.” That's when Cassandra and Harry Scott showed up at the BOE office.

“Both of those voters appeared at our office during normal business hours after receiving those acknowledgement cards. The new address that was submitted on these registration cards was actually the place of business for Ms. Cassandra,” Elections Board Director Sherry Poland told Hamilton BOE members at a [meeting last month](#). “She had not moved and did not complete the registration form.”



‘Trying to Defraud the Elections’

The false form was one of many suspect voter registration issues tied to the left-wing Black Fork Strategies. Election Board staff reached out to the company, which “provided information” on the canvasser responsible for the Scotts' voter registration forms, Poland said.

“We also received a registration form in the name of Henry Kissinger,” the elections official said at the public meeting. The statement was greeted by a smatter of laughter from some in attendance, likely at the thought of the late and renowned U.S. secretary of state registering to vote in Hamilton County. Staff compared the Kissinger listed on the form to voter registration and Bureau of Motor Vehicle databases. It was a mismatch every time, Poland said. Staff had more questions for Black Fork.



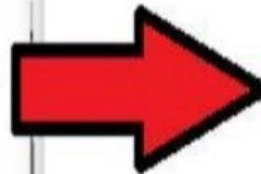

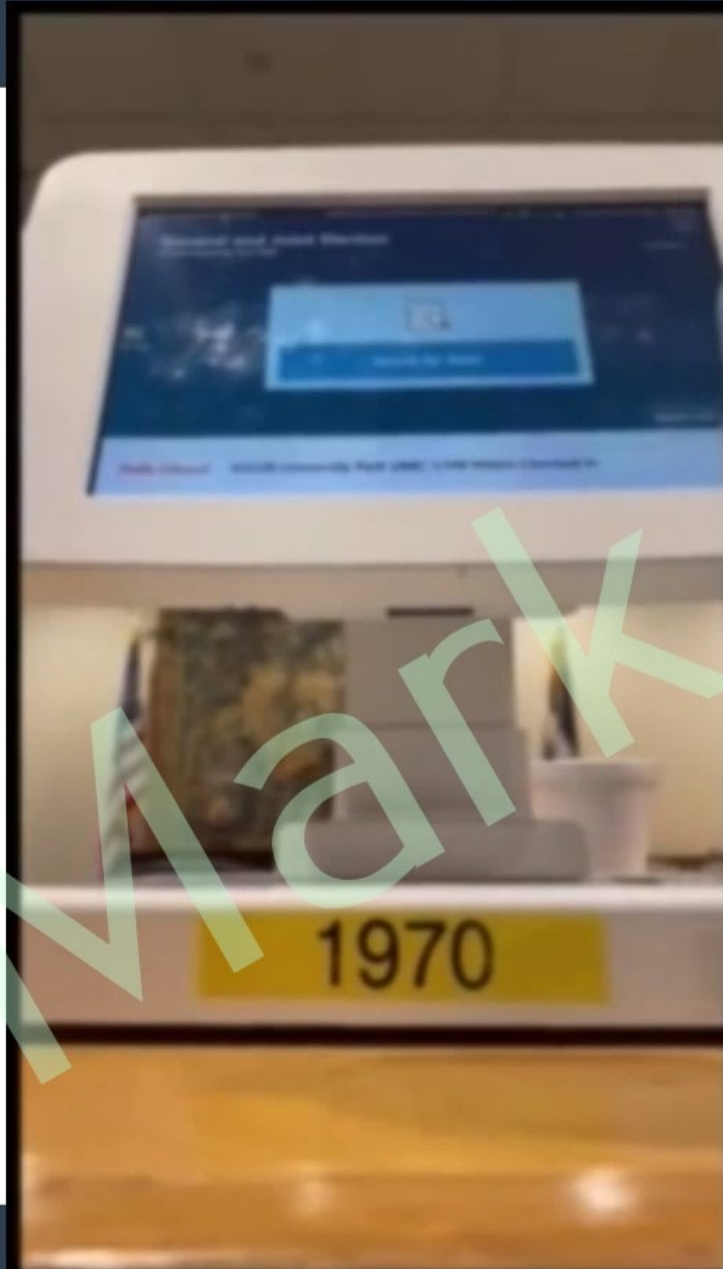

Macomb County clerk reports 'possible double voting' by 4 individuals

The Macomb County clerk's office said Thursday it's notified the state and the local prosecutor of "possible double voting involving four individuals" in last week's Aug. 6 primary election.

Clerk Anthony Forlini's office said in a statement Thursday that the alleged doubling voting — once by absentee ballot then again in person on Election Day — was first identified by St. Clair Shores Clerk Abby Barrett. Forlini reported the situation to Michigan Secretary of State Jocelyn Benson's office and Macomb County Prosecutor Peter Lucido's office, the county clerk said.

"We take this very seriously," Forlini said. "Voting twice is a felony. And if they knowingly did that, I expect the full length of the law to apply."

Forlini, a Republican, said the double voting wasn't "widespread fraud," and he believed the election administration software had warned local poll workers the individuals had already cast ballots.

Asked if he thought the individuals voted twice knowingly or by accident, Forlini replied, "They've got to do their investigation and talk to these individuals and see what they can come up with."

Benson spokeswoman Angela Benander said the alleged situation had been referred to Attorney General Dana Nessel's office.

Macomb County is Michigan's third most populous county. About 21% of Macomb's 726,541 registered voters participated in the Aug. 6 primary, according to the unofficial results.

About 13,000 of the county's ballots were cast in St. Clair Shores, which has 21 precincts. The alleged instances of double voting occurred in precincts No. 7, No. 15 and No. 16, according to the statement from the Macomb County clerk's office.

Instances of double voting in Michigan have been extremely rare, according to a 2022 report from the Michigan Office of the Auditor General, which examined the state's qualified voter file. The report found 99.99% of votes examined were not duplicates.

I then checked Okta for the week prior and you had a different IP address of 77.243.31.254 and it was showing a location of Serbia.

A candidate in Georgia who appeared to get few Election Day votes was actually in first place.

The discrepancy in a race for a county-level board of commissioners seat was blamed on a series of technical errors.

The candidate, Michelle Long Spears, was shortchanged by 3,792 votes in the District 2 primary for the Board of Commissioners in DeKalb County, Ga., that was held on May 24, according to newly-certified results released on Friday.

After conducting a hand count over the Memorial Day weekend and auditing those returns, election officials determined that they had drastically underreported the vote totals for Ms. Spears.

She received 43 percent of the vote, not 24 percent, as reported by an unofficial and incomplete election summary posted on May 25 on the county's website. As the top vote-getter, Ms. Spears qualified for a June 21 runoff against the second-place candidate, Lauren Alexander.

“I hope that this never happens to another candidate, in another race ever again,” Ms. Spears said. “It has been a nightmare.”

Election officials attributed the discrepancy to a series of technical and human errors, which they characterized as being isolated to the primary race.

They said that the problems, which they described as a computer programming error, began when a fourth candidate withdrew from the race late — 135 votes were cast for that former candidate. A redistricting error compounded the situation, according to the county.

CHEROKEE COUNTY, Kans. — We’re learning more on the events that lead to a mix-up in a Cherokee County Commissioner race.

The Cherokee County Clerk says an audit was done this past Friday and officials noticed a discrepancy that showed the numbers were correct, they were just under the wrong candidate. Image prints on the thumb drive for “County Commissioner District One” switched the numbers for incumbent Myra Frazier, and challenger Lance Nichols. A full hand re-count was done twice to ensure the accurate results of the vote and found Myra Frazier to be the true winner of the race.

The election software company has taken full responsibility for the error. The County Clerk just wants to ensure voters their vote will always count.

“I want to be as transparent as I can possibly be to the citizens of Cherokee County. And, I don’t want them to ever have to think that there’s anything to worry about when it comes to elections in this office,” said Rebecca Brassart, Cherokee County Clerk.

The County Clerk is now going through all of the thumb drives to make sure all the other races in the county and at the state-level are correct.

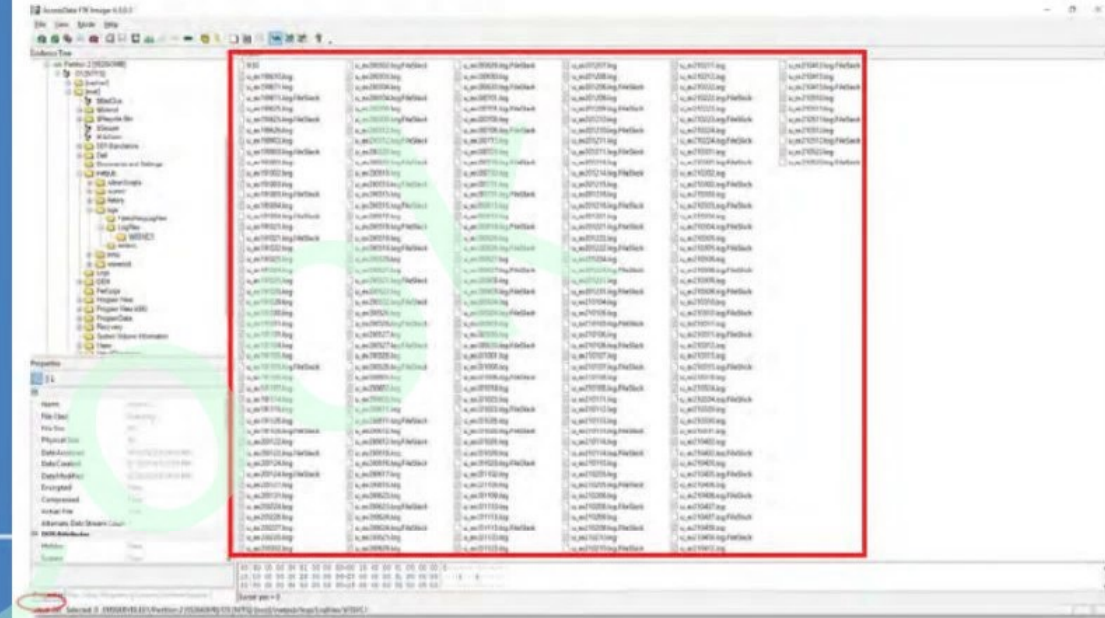
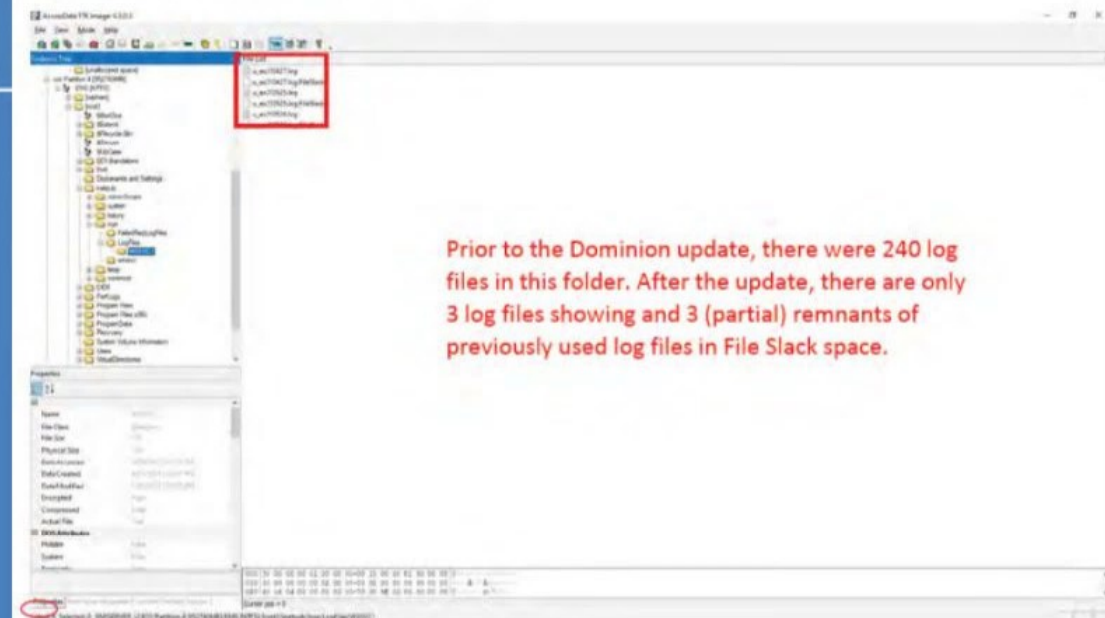


Figure 9 - EMS Server (5.13) Web Server Log Files After



Prior to the Dominion update, there were 240 log files in this folder. After the update, there are only 3 log files showing and 3 (partial) remnants of previously used log files in File Slack space.

The Key Objectives for this report were answered by this examination:

1. To determine whether D-Suite-implemented security requirements comply with the 2002 Voting System Standards (VSS)
 - a. Uncertified software was used on the system rendering the certification of the entire system and all elections conducted with it, Invalid.
 - b. Security protections required by law were almost completely absent
 - i. Other than a userID and an easily guessed or bypassed password, no authentication was required
 - ii. The firewall rule for access to the election database, ballots and results was unrestricted to any IP address in the world
 - iii. Together with the firewall rule, Microsoft SQL Server Management Studio (SSMS) enabled complete access to the entire election databases – not just to the 2020 election but to the elections of June 2019 through May 25, 2021.
 - iv. A self-signed encryption certificate was used introducing the potential for a man-in-the-middle attack
 - v. Thirty-five wireless devices (802.11, Wi-Fi) were installed inside election equipment and an additional wireless device was identified in a connected printer
 - vi. Any or all of these wireless devices could have connected to the Internet via the building wireless facilities
 - vii. “Purging” (deletion) of critical Audit Log data, as specified by DVS and directed by the Secretary of State⁷⁵, destroyed all records of connection to the Internet or elsewhere, all record of user activity, including programs run by these users, errors, and any record of the addition or deletion of votes and the alteration of election results.
 - c. **EACH of the compliance failures identified in 1.a. and 1.b. above are clear violations of the law.**

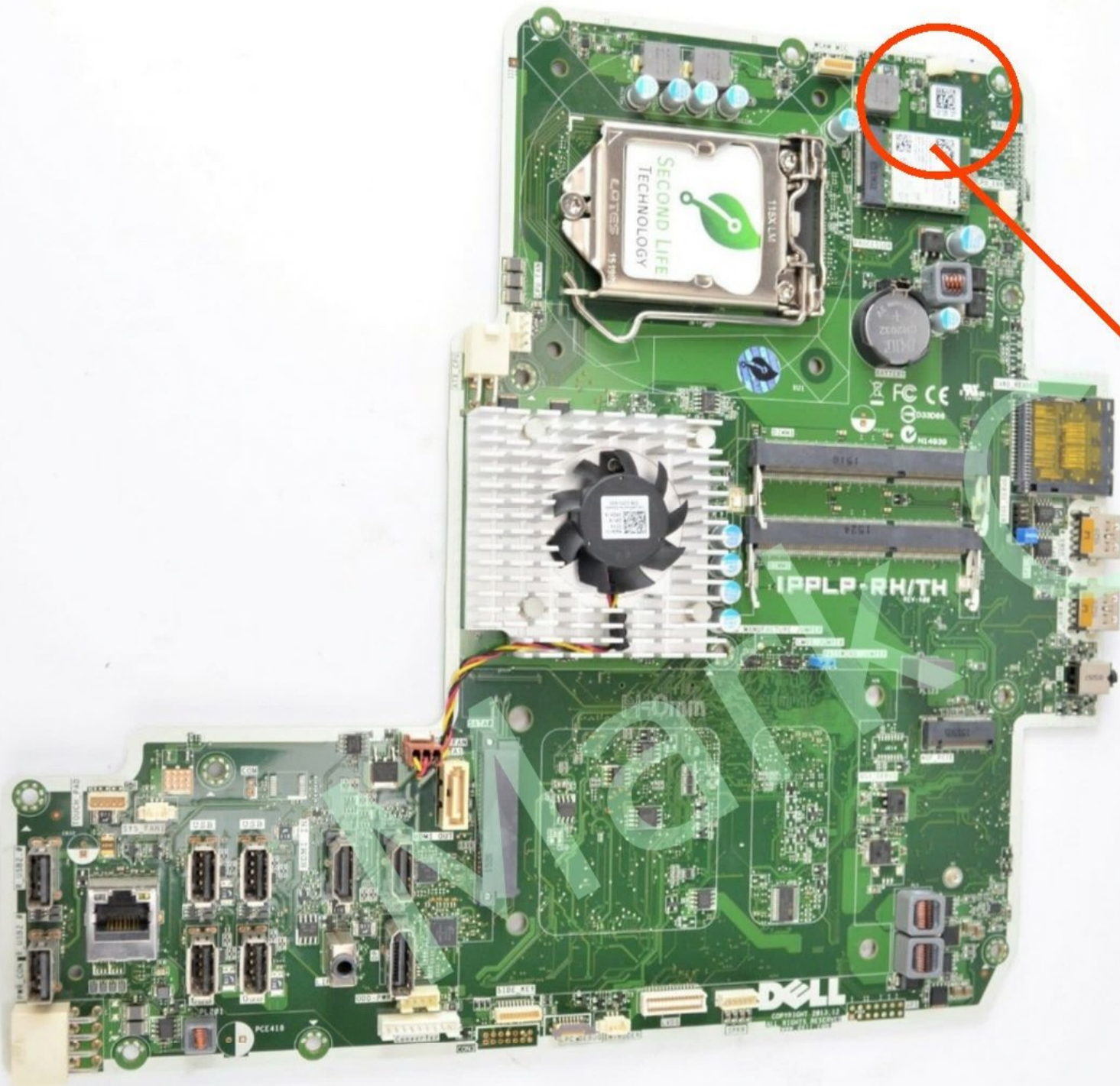

Conclusions

While the 4.14.A.1 build of the Democracy Voting System proved to mitigate four previously enumerated vulnerabilities, multiple medium and high vulnerabilities still exist within the suite of systems. A remote user could leverage most of the vulnerabilities across the network to obtain information about the system, voter ballots and results, or gain remote access to the system.

If remote access is gained, recovery of user credentials through system memory (RAM) analysis could be executed and used to modify the backend database of the EMS Server.

On Thursday, Georgia's 159 counties [finalized a hand recount](#), technically an audit, of the five million ballots cast in the election, reaffirming Joseph R. Biden Jr.'s victory but reducing his lead by more than 1,200 votes.

Georgia's secretary of state, Brad Raffensperger, a Republican, had [ordered the manual audit](#) as part of a new state law to ensure the accuracy of voting machines by comparing paper ballot counts with machine tallies. This was not an official recount, though the Trump campaign can choose to request [one](#) after the state's results are certified this week, as the vote margin between Mr. Biden and President Trump is below 0.5 percentage points.

In many counties, officials conducting the audit found [zero or single-digit differences](#) in their counts, and they will not change their original results for the state certification process. Yet at least four counties — Douglas, Fayette, Floyd and Walton — discovered missed ballots and will add these to their original counts.

In Douglas, Fayette and Walton Counties, the counting of paper ballots revealed that election workers had undercounted votes after missing memory cards, which held machine-cast votes. New voting machines adopted by the state in 2019 allow voters to use touchscreens to print ballots. The voters then verify the ballots and formally cast them by scanning, resulting in a paper record and a machine tally.

Floyd County officials discovered about 2,400 ballots that election workers neglected to rescan after a scanner failed and results could not be retrieved from memory cards. Officials attributed the error to "gross incompetence" on the part of the county's elections director.

Despite the errors in these four counties, election officials have said that there are [no signs of voter fraud](#) and that the new system is working as intended.

"These people are operating in it under the highest level of stress, in the most contentious election in their work life in the United States and in Georgia. So for the most part they are doing a really good job on this," said Gabriel Sterling, Georgia's statewide voting system implementation manager.

PREPARATION

The goal of this phase is to win the battle before most believe it is even being fought by creating weaknesses in the election system or enhancing existing weaknesses that maximize chance of fraudulent victory while minimizing the risk of ever being caught.

MAIN ATTACK

The goal of this phase is to cast and/or shift a sufficient number of absentee ballot votes to secure victory in a manner that minimizes the risk of detection. The number of ballots needed is determined by the projected voter turnout and the vote margins that would fit a plausible post-election narrative.

BACKUP ATTACK

The goal of this phase is to inject or shift a sufficient number of votes to overcome any deficit resulting from inaccurate voter turnout projections. Minimizing the risk of detection is no longer a primary concern.

DEFENSE

The goal of this phase is to prevent anyone from overturning the fraudulent election results.

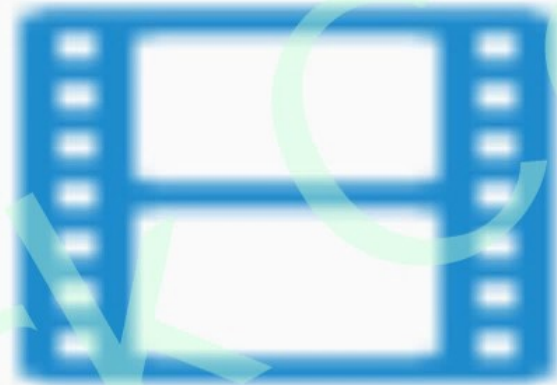

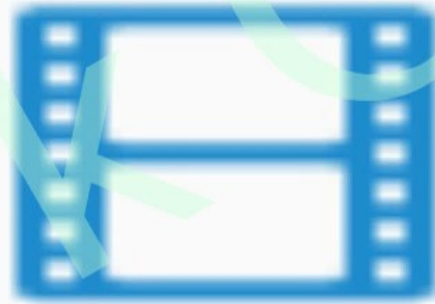
